Material Title: **Adoption Politics: Bastard Nation and Ballot Initiative 58**
 Author: E. Wayne Carp *Books* 2004 169 pages

The passage of Measure 58 in Oregon in 1998 restored the legal right of adopted adults to request their original birth certificates. This book reveals the efforts of the grassroots organization, Bastard Nation to pass this milestone initiative. It follows the campaign from its inception, addressing essential ethical questions raised by all sides of this complex issue.

Material Title: **Ayuda Para Niños!: Entendiendo Tus Sentimientos Sobre Tu Papá o Mamá En La Carcel o La Prisión**

Este cuaderno de trabajo habla sobre algunos de los problemas que los niños tienen que enfrentar cuando, so separados de alguno de sus padres (u otro miembro de la familia) por encarcelamiento. This workbook discusses some of the issues children face when they are separated from one of their parents (or another family member) by incarceration. Many children express anger, others become sad, depressed, frightened or embarrassed. The purpose of this workbook is to help the reader identify their feelings and give information on how to deal with those feelings. It is important for parents to understand that your children, or children in your care, may be experiencing a wide variety of feelings.

Material Title: **Beating the Odds: Crime, Poverty, and Life in the Inner City**

Material Title: **Implementing the Fostering Connections Act in Your State (CD)**

Parents and young people have shaped significant federal legislation recently, including the Fostering Connections to Success and Increasing Adoptions Act. This session will help you be part of implementing the Fostering Connections Act in your state—estimating how much your state will receive when it increases adoptions and places previously non-IV-E eligible children for adoption.

Material Title: **Legal Guide for Lesbian & Gay Couples, A (Eleventh Edition)**

Material Title: **Moving Forward: Making Sense of Our Complex Children (DVD)**

When children reach the later teenage years, many times they are not emotionally or developmentally ready for the challenges of independence. In this DVD, Dr. Federici discusses legal and financial options families have in order to stage their children through a slower and more gradual approach into adulthood. This volume sheds light on how to create the balance children with trauma histories need, without overwhelming them, to move them forward successfully.

Material Title: **Oregon's Legal Guide for Grandparents and Other Relatives Raising Children – 2016**

Many families in Oregon find themselves with the unexpected opportunity of caring for their relatives' children. The willingness to step up and provide care and support can be a gift to both the child and the relative. However, the relative needs to understand his or her legal options and obligations when raising a young child. This guide discusses legal topics grandparents and other relatives need to know when caring for a young child. Information applies to all minors in the elder's home.

Material Title: **Tell Me About When Moms and Dads Come Home from Jail**
Author: Judi Goozh *Children's Books* 05/21/2018 42

Ideal for use with children aged 6-11, this is a vital resource for supporting the wellbeing of children whose parent is coming home after spending time in prison. Using plain language and photographs, it reassures children and guides them through adjusting to their parent's homecoming. It explains which feelings the child and both parents might experience and the different challenges that everyone in the family might face, while suggesting ways to build new bonds with the parent. Included are activities to help children manage their feelings, tips for parents and professionals on how best to support them, and a list of resources for additional help and information.

Material Title: **Tell Me About When Moms and Dads Go to Jail**
Author: Judi Goozh *Children's Books* 05/21/2018 48

"This book will help you understand what is happening to your mom or dad who goes to jail..."

Ideal for use with children aged 6-11, this is an invaluable resource for supporting the wellbeing of children whose parent is incarcerated. It explains what jail is like and why some people have to go there, while reassuring children that their parent loves them, is safe, and is working hard to come home again.
